i(a). The specimen is not creating any visible images mentally.

i(b). The specimen seems again to have an understanding that he is being watched. He "speaks" to [REDACTED] in his mind. His emotional state is relaxed. He is mildly apprehensive, but assures himself that there is no issue.

"I am Hadrian Evans. No middle name. Are you still having trouble with my file?"

ii(a). There is a brief image of a woman in her late twenties. She is blond and exceptionally pretty. [REDACTED] tells me this is Amelia, who appeared in previous sessions with [REDACTED].

ii(b). The specimen is annoyed at the visual.

iii(a). The specimen reiterates his identity as "Hadrian Evans." He does this repeatedly throughout the session. [REDACTED] is reluctant to try a more aggressive approach. Nothing else of particular note is observed.
