*Note from Greer: Several inaccuracies appear on this list, most important to me, being the erroneous statement that the Malkavian Ignax was placed under my Accounting. This seems to be a misinterpretation of a public request made to me to show him around the city, which was certainly never construed to me as an official Accounting. The Prince and any other Kindred who were present in the city at that time should vouch for this.*

*In addition, I will also note that the name of Alastor Quinn has been misspelled throughout this document as "Quintis" and that as of this date Azreal should no longer have been listed as having status, or as being Sheriff, having defected to another Sect. These details, however, are fairly elementary and involve individuals not currently in the city.*

*Note from Greer: There appears to be some sort of confusion here as well, as Todd Walsh was never officially appointed to the post of Sheriff, and the announcement that he was removed was never made in court.*
