


It is hereby observed by my personage, and by Archons Bell, Keats and Johnny the Black that the following is what transpired between the two Kindred Nicolai Antonescu of Clan Tremere and Hadrian Evans of Clan Brujah.

1. On January 21, 2005 anno domini, while Hadrian Evans was Prince of the Domain of New York City, one William Isaiah Lansing (no Clan) tried to incite a declaration of praxis seizure in the name of then-Seneschal Darren West, who was at the time located in the Domain of Washington DC (Confirmed by Prince Vitel of that Domain). On this same evening, Nicolai Antonescu was paying a visit to the Domain of New York to meet with members of his Clan.
2. Upon hearing news of the praxis, Darren West had himself immediately transported back to the Domain of New York. During the period of his travel, Hadrian Evans called an assemblage of the Primogen Council, gathered at the Maupassant Room at Columbia Universe, and contracted Nicolai and his clanmates to aid in preventing Lansing or West from taking offensive measures against them. He assented and cast upon the location the rituals: [REDACTED] and [REDACTED].
3. Upon his arrival, Darren West seconded Lansing's declaration of praxis. Primogen Frederich von Sonderhausen (Clan Ventruie), Primogen Adam Jones (Clan Tremere), and Primogen Lillian Greer (Clan Malkavian) all declared their support of Hadrian Evans as ruler.
4. Hadrian Evans upon gaining formal recognition as Prince, invoked the Tradition of Destruction regarding Darren West and called for the *lex talonis* to be enacted on his person.
5. The assembled Kindred then collective shot West into torpor.
6. At this point Nicolai Antonescu requested of Hadrian Evans that he spare West's life in exchange for the boon of the two rituals and under the agreement that Darren West would be taken to Chicago and not be permitted to return to the city of New York nor to have contact with it's inhabitants.
7. On March 1, March 13, March 14, March 16, and April 25, 2005 anno domini, Darren West made contact via phone with Kindred known to be within the Domain of New York City (confirmed by Tremere recordings of West's personal phone)
8. On April 26, 2005 anno domini, Darren West returned to the Domain of New York.
9. On May 12, 2005 anno domini, Darren West declared praxis seizure over the Domain of New York, following Hadrian Evans departure from the city at my request.
10. On May 11, 2005 anno domini, Nicolai Antonescu made contact with Emanuel James Richardson IV, Clan Toreador, regarding the issue of Darren West's attempt at praxis.
